

# **Property – Location**





## **Existing Trail Opportunities in the Area**

- Lake Crabtree: 215 acres

   9.4 miles multi-use trails that allow hiking and cycling
- Umstead: 5,600 acres
  - $\circ$  20 miles of hiking trails
  - 13 miles of multi-use trails that allow horseback riding and cycling






## **Existing Conditions / Concerns**

- 10 miles of trails
- Built without RDU permission
- RDU concerned with trespassing, maintenance, etc.
- Exploring possible lease with Wake County to manage trail system, allow sanctioned use


## Site Development

#### Assumptions:

- No utility extensions required
- No improvements to Old Reedy Creek Rd.
- No environmental issues on the property
- No restoration/mitigation required for streams and buffers
- Most existing trails would be rebuilt to professional standards



### **286 Site Development**



- Rebuild ~ 7 miles of trail
- Add maintenance trail for vehicular access
- Gravel parking lot
- Well water and composting toilet
- Drop off/event area
- Small picnic shelter
- Estimated cost: \$3.0M-\$3.3M

#### Visitation Estimate – 286 Only

- Approximately 25,000 rides per year for 286
- Average mountain biker will use trail 11-13 times per year
- Approximately 2,100 unique riders each year





Based on 25,000 rides per year by 2,100 unique riders each year

- First year cost per ride: \$13.41
- Average cost per visit for all County parks: \$1.96
