THIS DEED made this 7th day of July, 1976, by Sir Walter Lodge No. 411 Independent Order of Odd Fellows, Incorporated, Grantor of Wake County, North Carolina, to the CITY OF RALEIGH, the CITY OF DURHAM, the COUNTY OF WAKE and the COUNTY OF DURHAM, Grantees;

WITNESSETH:

That the Grantor, in consideration of Ten Dollars and other valuable consideration to it paid by the Grantees, the receipt of which is hereby acknowledged, has bargained and sold, and by these presents does grant, bargain, sell and convey unto the Grantees, their successors and assigns, the parcel of land in Cedar Fork Township, Wake County, North Carolina, more particularly described as follows:
