Hinton, of Wake county, and state of North Carolina, Justine Davis Daught-ridge, and husband, E. L. DAUGHTRIDGE, Jr., of Edgecombe County, and state of North Carolina;

Mildred DAVIS Greene and husband, Ben F. Greene, of Burke County, and state of North Carolina, parties of the first part, and the United States of America, party of the second part:

WITNESSETH: That the said parties of the first part, for and in consideration of the sum of Two Thousand Eight Hundred Fifty and 00/100 (\$2,850.00) dollars, in hand paid by the party of the second part, the receipt whereof is hereby acknowledged, have bargained, and sold, and by these presents do sell, bargain, and convey unto the said United States of America, or its as- signs, all that certain tract or parcel of land containing two hundred and nine acres (209) more or less, located in House Creek Township, Wake county, North Carolina, bounded on the north by the lands of PAGE and Medlin, on the east by the lands of LANGDON Douglas and Gullely; on the south by Crabtree Creek and the lands of Adams; on the west by the lands of Duke and Moore par- ticularly described as follows:

47.3 chains x 66ft/chain is 3,121.8 feet

Beginning at Adams' corner in the Duke line; thence north 4 deg. 30' East 47.30 chains to a stake, Duke's corner in PAGE's line, thence south 85 deg. east 45.80 chains to a stake in LANGDON's corner; thence south 4 deg. 30' West 40.15 chains to a pointer, on Crabtree Creek, thence up the meanders of said Creek (950 feet according to former survey) to Adams corner, thence north 65 deg. west 36.20 chains to the beginning containing 209 acres, according to map of Mrs. Boris B.
